The supply of the outdoor area with electrical installations is only possible to a limited extent and with increased effort. Installations in the outdoor area therefore require an individual quotation.

Cancellation does not affect the exhibitor's exhibitor to pay the agreed rent.  
This reduced as follows, depending on the time remaining until the start of the event:

- to 50% of the rent in accordance with § 6, 6.1 of the General Terms and Conditions in the event of cancellation up to six (6) weeks before the the event;
- 90 % of the rental fee in accordance with § 6, 6.1 of the General Terms and Conditions in the event of a cancellation up to four (4) weeks before the event.
- The regulation shall apply mutatis mutandis to the partial.

Cancellation must be made in writing to the organizer. For the calculation of the deadlines, the date of receipt of the written notification to the organizer.
